Behind the Scenes

“THINGS ARE NOT ALWAYS WHAT THEY SEEM; THE FIRST APPEARANCE DECEIVES MANY; THE INTELLIGENCE OF A FEW PERCEIVES WHAT HAS BEEN CAREFULLY HIDDEN.” PHAEDRUS

The Screwtape Letters by C.S. Lewis explains, “A few centuries ago the art of *argument* was the way to keep a person out of God’s reach; executed by a chain of reasoning. At that time humans still knew well when a thing was proved and when it was not; if it was proved they really believed it.” Then Lewis shows the current status quo of a dozen of “incompatible philosophies” established in a person’s head that were placed by weapons, such as, the “weekly press”. Spinning that all doctrines *only* exist as “academic or practical; out worn or contemporary; conventional or ruthless.” Doctrines are no longer viewed as “true or false.” This is how society has succumbed to believe our government “knows best” and our constitutional rights by their programs and agencies need to regulate them. But what if this is the *deception*? Let us look at a system formed by academics said to be technically contemporary and conventional, that views all dissenting analysis as ruthless. First, for us to understand how we fell for the rouse, we need to look at the history of the United States voting system. Then the deception will expose the perpetrators and their secrets. Lastly, suggestions for Oregonians to achieve integrity of our vote.

In 1993 President Bill Clinton signed the National Voter Registration Act, known as the

Motor Voter Law. It directs states to encourage voter registration. The Act requires a Federal Elections Commission (FEC) voter application be available with a driver's license application; mail-in applications; in-person application at an assigned office; or delivered to a residential registration site. The FEC allowed the states to designate agencies for voter registration. The motor vehicle license application or renewal will serve as the application for federal

elections voter registration signatures. The Motor Voter law also set the criteria to remove names from eligible voters’ lists (rolls); only by death, criminal conviction, change in residence, mental incapacity, or voter request. A failure to cast a vote cannot remove a person from the voter rolls. Good intentions in the law are to increase a new voter base, maintenance of existing

rolls, and the rules for voter roll removal. It seems to be conventional, or is it?

Oregon was the first entirely mail-in primary for the federal election which took place in 1995 and the first general election in 1996. Oregon became the first state in 1998 to pass an initiative requiring that all elections be by mail. In 2000 70% of Oregon voters approved a ballot initiative to make Oregon an all vote-by-mail state.

Accordance to the 2002 Help America Vote Act (HAVA), the Secretary of State’s office

established and maintains a statewide voter registration list through the Oregon Centralized Voter Registration (OCVR) system. Individual voter record changes are in an audit trail and available to the system administrators. Governance includes a Change Control Board, consisting of twelve county and state personnel.

On March 1, 2010, Oregon became the fourth state in the nation to provide online voter registration. The signature on their driver's license, permit or ID card will serve as the signature for their voter registration card. Election officials check signatures to validate the mail-in ballots for Oregon elections.

On January 1, 2016, Oregon became the first state to automatically register eligible citizens who are not currently registered when they apply for an original, renewal or replacement license, permit or ID card through the DMV. The law, known as Oregon Motor Voter, passed the 2015 Legislative Assembly to modernize the federal "Motor Voter" law; requiring DMVs to offer voter registration services. This opt-in model is mostly executed by DMV employees asking citizens who are

getting or renewing a driver's license if they would like to register to vote. Under the Oregon Motor Voter law, a non-registered to vote Oregonian will receive a card and a pre-paid postage return envelope from the Oregon State Elections Office. They will have three options: Do nothing and the system registers the voter as a nonaffiliated voter; choose a political party by returning the card; or use the card to opt-out of voter registration. Once registered, an individual will automatically receive a ballot and instructions in the mail two weeks before an election. It seems to be academic, or is it?

In the summer of 2019, Oregon state legislature passed a law issuing standard licenses to undocumented immigrants. The law, originally introduced in the Oregon House as HB2015 and later signed into law as the "Equal Access to Roads Act", eliminates the requirement for persons to prove US citizenship or legal presence in the US to be issued a non-commercial driver license or an

identification card. Driver and Motor Vehicle Services spokesperson David House said, “There is no risk of people without proof of citizenship or legal residency will get registered to vote by obtaining a driver’s license. The DMV already requires all applicants to show proof of citizenship or legal residency to get a license. Only those who are citizens have their names and information passed along to the Secretary of State for potential voter registration. That practice will continue.” In a Gateway Pundit exclusive a non-citizen in Oregon recently came forward and explained how the Oregon government automatically registered her to vote. “I just want to highlight to American citizens this does happen. I do not know why there is this blind belief that it cannot happen. It does happen, it happened to me,” she ended up getting registered to vote without even knowing it, and had ballots sent to her.

Oregon started tracking their ballots with BallotTrax; which twenty-five states used in the 2020 election, an estimated sixty million tracked ballots since 2009. Developed by BallotTrax (ballottrax.com), a Denver healthcare-based company i3Logix. All states send ballots with unique numbers linked to the voter. USPS scans this number and sends its status to the voter or a third-party tracking service. They track all mailed ballots and then they sell the service to

county clerks, politicians, and paid individuals/businesses. County Clerks can digitally check returned and unreturned ballots by the minute tally. Politicians can digitally receive all mailed addresses, then follow up with a vote-for-me postcard.

USPS knows the unreturned mailed ballots roll and sends that to anyone who pays for this information. Seems to be technical, or is it?

In 2017 Oregon Senator, Ron Wyden (D), sent a letter of concerns to SLI Compliance about the manufacturers and government consumers election systems, and the Voting System Test Laboratories accredited by the U.S. Election Assistance Commission (EAC). He asked if they were aware of data breaches. If there are security officer(s) or outside firms to conduct penetration tests, or if they have implemented NIST Cybersecurity Framework 1.0. Also, he requested certified machines. His plausible deniability came from a briefing sent to congress from former Director Brennan.

On March 26, 2019, democrat senators sent a letter to three of the voting systems manufacturing companies. The concerns were regarding the machines not being updated for nearly two decades, foreign adversaries undermining the election system, and there is no ability to conduct a reliable audit. On December 6, 2019, democrat senators sent another letter to three investment election technology vendors with connections to Dominion that are responsible for developing, manufacturing, and maintaining most voting machines and software in the United States. Companies, owned by private equity firms and responsible for voting machines, “have long skimped on security in favor of convenience” and are “prone to security problems.” These companies have “incredible power” over unknowledgeable local election officials. The EAC warned election officials that “[i]f you do not manage the vendors, they will manage you.” Homeland Security warned that voting machines are “falling apart” and “run on old software that will soon be outdated and more vulnerable to hackers.” Also, there were reports of machines in the 2018 election of switching votes; scanners were rejecting paper ballots; and busted machines were causing long lines.

Private company contracts for voting equipment and other services have no laws requiring breach disclosures or third-party security auditing. These contracts bar our

federal and state governments from hiring a security firm to investigate the machines they serve to voters. Agencies and legislatures ignored discovered breeches from legal sources. In 2018 the FBI organized briefings with elections officials and politicians in Maryland to let them know that a company-ByteGrid's finances come from AltPoint Capital Partners. Their largest investor is Russian oligarch Vladimir Potanin, said to be a close associate of President Vladimir Putin. The company's fund manager is a Russian-born man who changed his name to Gerald Banks. A recent report reveals China using a tiny chip to infiltrate U.S. companies by placing the microchip, as small as a grain of rice, on motherboards during the manufacturing process.

Unfortunately, secular manipulation directs clever ideas into an unlawful agenda. A documentary exposed that paid operatives become "mules" to "stuff" ballots. There are entities that pay for the USPS information and then print "extra" ballots to assign the names of the unreturned ballots. Last, they pay for mules to stuff these ballots into ballot boxes. The movie *2000 Mules* by Dinesh D'Souza shows tracking and videos of these mules stuffing ballots in the 2020 elections. The tracking used in the movie is the same tracking the FBI used to convict Americans in the January 6th "Insurrection".

A system decides the outcome of every state before the election and regulated at the county level. The inflation of Voter Registration Databases happens before the election to give a "credit line" of phantom names to use in the algorithm programmed machines. During the election they monitor the databases through hacking and tracking, such as through Verity Relay data transmission relay software built into the machines. An email obtained by Oregon's Marion County Clerk, Bill Burgess, states Marion County elections used Verity 2.4 in the 2020 election. Thus, they can determine to stuff more ballots, manipulate votes, and restart the machines' algorithms. They convert more ballots creating phantom voters and ballots are than mailed. They can print the ballots, fill them out,

and mail them in. They can then order and send ballots because they have complete access to the rolls. After the election they pair last minute voter IDs with Phantom Voters. The key idea is to assign every stuffed ballot to a voter in the rolls.

Last, they will "clean up" the voter rolls AFTER the election. The elections are all computerized and electronic. The problem is that every step is a hackable step.

April of last year Dr. Douglas G. Frank, world-renowned physicist with sixty peer-reviewed scientific publications, presented to Mesa County Clerk Tina Peters

that two thousand dead people voted in the 2020 Mesa County election. They found out the election workers did not properly check those ballot signatures. That is when she realized there may be fraud. It suggested that Peters back up all the hard drives of the machines before the primary election, as most Clerks do not know how to preserve all records for the required two years and are in violation of the law. He sent experts to back up the records before Dominion reprogrammed the machines and to overwrite all the records. After Dominion reprogrammed, the experts backed up the records of the machines again. They were able to obtain what was changed from the reprogram of the machines. Then after the election they backed up the machines for the last time. They were able to obtain all the deleted logs of the internet connections and manipulated reassigned ballots. Dr. Frank was able to use an algorithm to find the phantom voters; canvassing confirmed those phantom voters.

The hacking of the County Clerk's offices throughout the country is a second one would know who voted and the unreturned ballots status. Dr. Frank found thousands of emails the night of the election. In Wisconsin there are one hundred megabytes of emails from the county clerks to the Center for Technology and Civic Life (CTCL-Zuckerberg Organization).

The emails have revealed a CTCL employee asking for the names of people who have voted to the minute tally. Then later in the week replies to the Milwaukie clerk that they

already have all the names from another source, they did not need the official connection. The voting machines documentation in the Mesa County Report reflects having the technology to reassign ballots to other voters, shown in forensic images of the machines and the team documented the execution of these reassigned ballots.

In November 2020, Director Steven Trout of Oregon's Elections Division wrote a memo to the general election Secretary of State candidates for transparency of Oregon's dismal voting systems. He also stated that he was interviewing for new jobs, which was the excuse of firing him. He explained the constant change in the executive team created a lack of strategic vision, plans for the agency, and the staff are not focused due to the lack of vision and leadership. Even with CISA, Department of Homeland Security, FBI, TIGER team, Oregon National Guard, Oregon Office of Emergency Management, Oregon Titan Fusion Center, USPS, and Oregon Chief Information Security Officer's office cooperation; he expresses the Elections Division still struggles to get support from the agency support divisions. He iterated there are technology challenges; systems are old and out of date versions, some of which Microsoft no longer supports. He explained the elections systems are running on Windows Server 2008, all Microsoft support ended on January 14, 2020; there is no security. Also, the public facing websites are single threaded through one power supply on the capital mall and one internet connection. ORESTAR and OCVR are outdated and unable to accommodate modern tools. It was promised to Oregon's 36 counties that current technology standards would be used when they gave up their own databases 15 years ago. Summer budget cuts laid off positions at the Elections Division. Elections Division received \$6,029,047 in HAVA funds and \$5,656,663 in CARES Act funds. But legislation did not authorize the elections division to spend a penny. Oregon should have returned all the unused CARES Act funds; Oregon was not able to match the 20% required. Last, a social media/Public Records position was rejected

by the legislature, leaving a hole in transparency to the public making it almost impossible to query a public records request.

In 2019, Kate Brown selected Bev Clarno (R) to replace Secretary of State (SOS) Richardson after his death. Clarno sent a text message to Trout, firing him after his memo to the candidates. Also, after November 2, 2020, the webpage listed no elections director. He was "laid off" by Clarno before the election was certified. Then Rob Bovett, Oregon Association of County Clerks lawyer, wrote a letter to newly elect Secretary of State Shemia Fagan directing her attention to Trout's letter with concerns of the OCVR system. Bev Clarno did not address or work on these concerns before the election, they were suppressed. In 2021, Judicial Watch uncovers dirty voter rolls and sends a letter to Fagan. Inactive voters, such as dead and double voting, were reported. In Marion County only one removal reported in two years. Eleven other counties reported similar low removals pursuant to Section 8(d)(1)(B) The National Voters Registratoin Act of 2993.

A week before Oregon's 2022 primary election the ORESTAR state campaign finance reporting system (campaign finance records published) hosting provider had a ransomware attack. Also, Oregon's Attorney General, Ellen Rosenblum, had to admit in an article that Oregon election machines are online. Then, legal documentation in a lawsuit (Washington County vs Tim Sippel) reflect Oregon elections officials have inadvertently admitted that voting systems are vulnerable to attacks, even unconnected networks. Last, canvassing certain counties are documenting illegal voting may be up to 30%. My questions are, "Why did SOS Shemia Fagan join a county lawsuit to stop canvassing and audits in that county? Why did legislatures conjure up HB 2323 law (in committee) to suppress Oregonians rights of their freedom of speech to question any part of elections? Why did Oregon counties receive illegal money through CTCL-Zuckerberg, a private company that influenced the elections throughout the United States as New York Post has noted? So many more questions but let us now explore what an Oregonian can do to be involved in making our elections

safe from fraud and a true freedom, adhering to our Constitution. It does not matter what political party an Oregonian identifies with; this is about our voter sovereignty in the United States of America. Voting integrity governance is by the people for the people.

First, Oregonians need to check their voter registrations at State of Oregon: Voting & Elections - Voting & Elections, Vote Reference, and even call to check who voted from their address. If an Oregonian has discovered fraud, contact the Voter Integrity Project, and sign a declaration of facts to the fraud.

Educate yourself on how our system is supposed to work and where the fraud is coming from. Search the letters mentioned, look up www.cleantvoterrolls.com, Help Prevent the Spread of Oregon Madness - Voter Integrity Project, and www.joncus.net. Read the Black Box Voting by Bev Harris for free Black Box Voting book: FREE - BlackBoxVoting.org. Then watch

Frankspeech.com videos in The Moment of Truth Summit.

Get involved in your communities, become a Precinct Committee Person for your political affiliation and demand transparency in the voting process. Demand from your county election office to do an audit of the ballots that includes canvassing. Do not allow the state to create a cursory audit, which is when the state gives the "allowed" audited information. The only audit that will catch voter fraud is canvassing and comparing to voter rolls. **BECOME INVOLVED.**

A secure election day voting system is an in-person paper ballot vote (NO MACHINES), ID checked for legal status, and ballots to be hand counted on the day of the election. “BEAM ME UP SCOTTIE”

The fourth industrial revolution is imminent, a wave of technological innovation that will automate humanity; a fusion of the physical, biological and the digital. But this year’s big venue is the Metaverse, technocracy to control the inward self of humanity. Also, Dubai held the 2022 World Government Summit. Their main concept is of “transhumanism, human society can and should be transformed by technology, a global phenomenon, and it’s taken very, very seriously by world leaders.” A Dubai Municipal Officers’ discussion was to implement the infrastructure of the Metaverse 5G required to allow virtual and augmented reality to work conjointly.

Technology allows the elites to control the public’s mindset. We hear about Comcast, Blackrock, and other multinational corporations; but we should realize their direct influence in technology is cultivating our state of mind. Mergers of big pharma and technology are setting humanity on top of a fence. The WEF founder and chairman, Klaus Schwab states, “We are on the hinge of history, right now.” He is correct, but what side of the fence should we

take? One side is an opportunity for the Elites but may be tragic to ordinary people. Is the population ready to agree to the transhumanist fusion of man and machine? Are you ready for transhumanism?

The Elites revealed the 2030 Great Reset agenda. First, they need to cease our banking system for complete control, this has already started in the United States. On March 7, 2022, President Biden signed an Executive Order to start the Central Bank Digital Currencies (CBDC). China, Canada, Brazil, Germany, Austria, and Australia have been rolling out their digital currency system for a while. This dishonest system shows as “a great reset to stop theft, fraud, and for a more controlled money system.” The WEF stated we will be on a “sharing” economy; our government will own and deliver everything needed. An algorithm, which knows your needs more than you, will decide your choices. The CBDC will be programable, as governments will be able to put any rules, they seem fit. Spending your money will be where they deem appropriate, or access being cut-off for non-compliance. But can we trust all governments to control our way of life? With the turmoil throughout history and in the recent

Covid pandemic, I beg to differ.

The second step on the agenda is total surveillance technology for the planet,

requiring a new digital form of identification. Their deceptive promotion is for more access to all basic services. The government will control everything connected to a person’s life: Travel, social media, food, and bank accounts are a few of the luxuries. Schwab declared the Covid-19 pandemic, “represents a rare but narrow window of

opportunity to reflect, reimagine, and reset our world.” He was referring to humanity accepting governments using the pandemic to take more power. Also, stated by Yuval Noah Harari, Klaus Schwab’s advisor, “Surveillance- People can look back in 100 years and identify the Corona Virus epidemic as the moment when a new regime of surveillance took over; especially under the skin, an ability to hack human beings.” The elimination of our basic right to privacy, the destruction of our constitution. We will own nothing, even our bodies, mind, and soul.

The third step will be ranking humans, based on every action a person will take.

This scoring, the Social Credit System (SCS), said to be regulating social behavior, and improving the "trustworthiness" of citizens. China’s SCS program initiated regional trials in 2009, before launching a national pilot with eight credit scoring firms in 2014. In October 2019, Professor Kui Shen of the Law School of Peking University published a paper in *China Legal Science*, suggesting that some of the current credit policies violated the “rule of law” or “Rechtstaat”: They infringed the legal rights of residents and organizations, possibly violated the principle of respecting and protecting human rights, especially the right to reputation, the right to privacy as well as personal dignity, and overstepped the boundary of reasonable punishment.

The fourth step is for human-centered and holistic systems in “established institutional silos” to focus on nurturing effective ecosystems of social innovation, known as fascism. The WEF requirement to remove God from humanity warrants fascism to exist. Harari, Klaus Schwab’s advisor states, “All of life was subject to the laws of natural selection and the laws of organic biochemistry. Now this is about to change, science is replacing evolution of natural selection with evolution of intelligent design; not the intelligent design of a god above the clouds, our intelligent design in our IBM CLOUD, the Microsoft CLOUD.” Also, he stated, “History began when humans invented gods, and will end

when humans become gods.” Yet he talks as if humanity is not valuable, “The big political and economic question of the 21st century will be, ‘What do we need so many humans for?’” Then he mocked controlling humanity, “To keep them happy with drugs and video games.” He has commented that the future is about inorganic humanism. AI will be the dominant life form on earth and beyond earth. The illustration of this ungodly system is in Luke 2:29-36, the parable of the fig tree and all its leaves, “29 When they sprout leaves, you will know that summer is near.... 34 and that day will close on you unexpectedly like a trap. 35 For it will come upon all those who live on the face of the whole earth.”

Let us remember that the WEF is an organization of the most powerful and richest individuals in the world. But we have not voted or asked them into existence. We the People have the right to say No! We together, with integrity and responsibility, can stop this One World Government. But it is up to us.

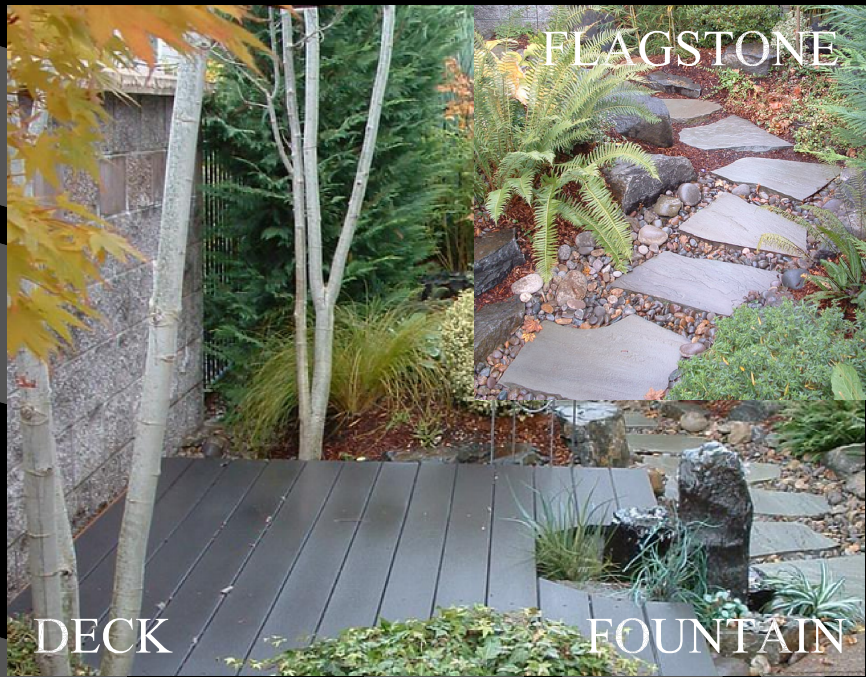

Linda and I are committed to honoring our Lord through Snook's Saw Service Inc., a business that the Lord has entrusted to us as stewards since 1977.

It has been used as a platform for ministry through the years. We have been so privileged to share the gospel of Jesus Christ and our love for the Lord, with our employees, customers, and vendors, as He presents the opportunities. We have had the joy of seeing some come into a relationship with Jesus.

Dave has held Bible studies in the office, and he has accepted opportunities to facilitate two different groups of businesspeople, through the Christian organization, Christ at Work.

Their mission is to teach business owners how to use their business, which God has entrusted to them as a platform for ministry. Dave has seen them grow in Christ and lead others to Christ. These meetings were held in the conference room of attorneys Dan Hill and Vance Day. Of all the blessings we have experienced from the Lord there are two that really stand out.

First: In 1997 our business was in a 2000 sq. foot building, and it was becoming very cramped. Across the street was a 4500 sq. ft. building that housed a printing company. The building was grandfathered into a residential zone.

Dave had previously been inside and knew that it would accommodate our business nicely. When the print shop closed and the building was for sale, Dave inquired about buying it. The city of Salem's zoning department required a "like" business to purchase and inhabit the property due to the "grandfather" zone situation. They also require that the building had to be in continuous use. That means the building could not stand empty for over one year, or it would lose its grandfather zoned status and convert to residential status. Since there were so many issues and our business didn't seem to meet the criteria, we were unable to purchase the property at that time.

About 18 months later a building contractor purchased it and made some improvements. They leased the building out to a telemarketing company, or so he thought. To us the building appeared empty for those 18 months.

Meanwhile, our business outgrew our building. We found a larger building to lease which we could afford; a 3500 sq. ft. building, at our maximum of \$1450.00 per month. One morning Dave went into work and saw police cars across the street.

The front door was open, so he went in to find out what was going on. He discovered the building had been used to grow marijuana. This was back when marijuana was illegal to grow and possess. The inside of the building was lined with Mylar. There were grow lights throughout, a drip irrigation system. All the switches and outlets were sealed with silicone to keep the smell in. A thief had broken in and stolen the marijuana plants.

The owner of the building was unaware his renters were growers. This totally disgusted him and he wanted to be rid of the building and his renters. He asked if we were interested in buying the building. We told him yes, but the city would not let us occupy it due to the zoning issue. We didn't know if we could get financing at this time. We had committed to renting another property.

He said that he would talk to the city and asked us to apply for financing. We called our banker on Thursday afternoon. Our banker stated that we would need enough money for electrical upgrades, moving, and other expenses. So, he arbitrarily included those costs into the loan.

The following Monday, we got a call from the title company asking if we could come down and sign the loan papers.

We were shocked and puzzled. We told them that we had not heard back on financing yet. Nor had we received a letter from the city we met the

zoning requirements. The title company stated that the financial papers were at their office, as was a letter from the city allowing us to occupy the building. We were amazed, this all happened over a weekend without us doing anything.

When does the government or a bank ever move this quickly?!

Since the building appeared to be empty when the city looked at the power records, they saw that it had been in continuous use--thanks to the growers. Grow lights use a lot of power!

We signed the papers that Monday. It turns out, our loan payment was \$1450.00 per month. Exactly the amount we could afford; the amount we would have paid to lease the other property.

We contacted the owner of the building we were going to rent and advised him of the miraculous event that led to us being able to purchase instead. He mentioned that he had passed up 5 other rental requests for the space. He was happy for us and understood why we needed to back out of our agreement.

He only asked if we would do one thing for him. That was to pray that he would get a good

renter. Of course, we would pray!!

The next day, the woodworking business adjoining the space we had declined, called him, and asked if they could expand into that space. Which they did. God used us, to hold that space until the woodworking business was ready to expand. 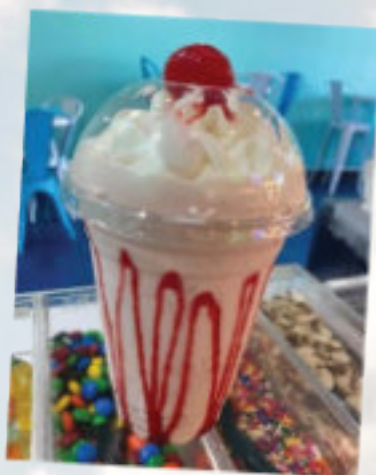

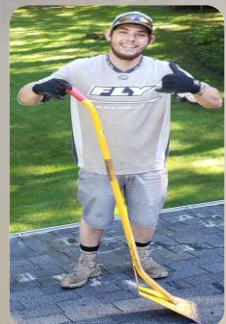

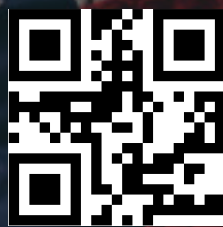
